Interview of eligible candidates will be held from 3rd September 10.00 A.M on wards as per schedule notified below, in Conference Hall, 1st floor OPD block .

For appointment against posts reserved for SC/ST/OBC category: only candidates having OBC certificate issued by the Competent Authority of GNCT of Delhi shall be eligible. For SC/ST's: SC/ST certificate issued only from the Judicial/Revenue Authorities as per notice in MHA OM No. 42/21/49/NGS dated 28-01-52 as revised by the Deptt. of pension and AR letter No. 36012/6/71/Estt.(S.C.T.) dated 29-10-77, shall be accepted. For persons with disabilities candidate: 3% reservation under section 33 of the Persons with disabilities Act. 1995 will be followed as per Govt. of India Rules(Certificate issued from Competent Authority).

Candidates who are working on adhoc basis will have to apply afresh.

ELIGIBILITY FOR THE POST OF SENIOR RESIDENTS:

1. **QUALIFICATION:** MBBS with P.G. Degree/Diploma/DNB in concerned specialty from a recognized university/Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & ad hoc period.
2. **Age limit:** 40 years for General candidates, 45 years in case of SC/ST & 43 years in case of OBC candidates & for persons with disabilities further relaxation of 10 years as per provision, on the closing date for submission application.
3. **Pay scale:** Rs.15600 – 39100/- (Grade Pay-6600/-) plus admissible allowance.
4. Appointment will be subjected to medical fitness & verification of certificates of education qualification/age /caste/PH/DMC etc.
The appointment will be made initially for a period of one year and will be extended further on yearly basis upto a maximum of 03 years, on the basis of satisfactory Work & Conduct Report from the concerned HOD and a written request from the Doctor concerned. Senior Resident may be assigned duties in Emergency Deptt. as & when required in case of any exigency.

In case where no fresh candidates are available, candidates who have completed 03 years of Senior Residency and are willing to serve as SR, shall be allowed to appear in the interview. A separate merit list will be prepared for fresh candidates and for those candidates who have already completed 03 years of Senior Residency. The fresh candidates would be called first for appointment.

The appointment will be governed under Residency Scheme .

Please Note:

1. Only Orthopedically disabled candidates are eligible for PH Category (Medical certificate from the Govt. Institution is required) and the minimum degree of disability required is 40%.
2. No TA/DA will be paid for appearing in the interview.
3. The number of vacancy of SRs may vary.
