CONDITIONS OF APPOINTMENT

- 1. The candidates shall be on probation initially for a period of two years in accordance with Rule 9 of the High Court of Karnataka Service (Conditions of Service and Recruitment) Rules, 1973 as amended from time to time.
- 2. The Candidates shall be taken on duty only on satisfactory proof of genuineness of original certificates to be produced by them at the time of reporting for duty.
- 3. The seniority inter-se between the selected candidates will be in accordance with their ranking in the final selection list.
- 4. The candidates have to report for duty within 15 days from the date of receipt of the Order failing which their name shall be liable to be cancelled from the final selection list.
- 5. If any of the documents so produced by the candidates in support of their claim found to be fake, then their candidature is liable for rejection without any notice.
