- i) Age: Proof of age as recorded in SSC certificate or equivalent.
- ii) Qualification: Original/Provisional Diploma in Electrical Engineering (or) any other equivalent qualification.
- iii) Caste Certificate, if any, issued by Revenue Officer not less than the rank of MRO (latest by 6 months i.e. on or after 01.07.2014) or Permanent Caste Certificate, in respect of SC/ST & BC candidates clearly indicating the Sub-Caste and group (**Proforma in Annexure-I**).
- iv) Physically Handicapped (OH) certificate indicating the minimum 40% of disability issued by District Medical Board.
- v) Study Certificate from IV to X Class (**Annexure-II**)
- vi) Residential Certificate issued by the Officer of the Revenue Department not below the rank of MRO/Tahsildar in independent charge of Mandal as the case may be (In respect of candidate who has not studied for part or whole period

in any Educational Institutions upto SSC) (**Proforma in Annexure-III**). Residence Certificate will not be accepted, if a candidate has studied in any Educational Institute up to S.S.C. or equivalent examination, such candidates have to produce study certificates invariably.

- vii) N.O.C from the employer (if already working in any organization).
- viii) **Hall ticket issued for Written Test along with present call letter.**
- ix) In-service contract worker shall submit certificate from the concerned Divisional Engineer evidencing length of service, continuity of in service as on 28.04.2015 as contract worker/with recorded evidence to be certified by the concerned Divisional Engineer and in respect of Corporate Office General Manager/HRD or Divisional Engineer/O&M and with recorded evidence of EPF No. in his name to be certified by the concerned Divisional Engineer. In respect of Contract workers of Corporate Office, EPF certification of AO/CPR.
- x) The in service contract workers shall submit the Affidavit certified by Notary (Public) in the prescribed format enclosed (**Annexure-IV**).
- xi) Latest passport size photo.
- xii) **One set of attested copies of all the above certificates, as the case may be.**
