The list of qualifying candidates may be drawn up basing upon the aggregation of the marks secured by them in Stenography Test, Written Test (English) and Computer Test in descending order, and out of the said list the candidates numbering five times the vacancy, (from General

category and separately from individual reserved categories) shall be called to face the Viva Voce Test subject to the candidates from General category securing atleast 35% and the candidate from reserved categories securing at least 30% of the aforesaid aggregated marks. Further, on the basis of aggregation of marks secured by the candidates (shortlisted for Viva Voce) in all rounds of selection test, the final merit list for general category and separately for individual reserved categories shall be prepared according to descending order of marks secured by the candidates.
