1. MODE OF APPLICATION.

- 1.1 A candidate may make an application in any Revenue District of the State irrespective of his / her home Revenue District subject to condition that he / she shall apply in respect of one Revenue District only
- 1.2 The candidate shall have to furnish an affidavit / undertaking to the effect that he / she has not made application for engagement of Sikshya Sahayak in anyone Revenue District other that the Revenue District applied for If, on verification it is found that the candidate has applied in more than one Revenue District for engagement as Sikshya Sahayak, his / her application shall be rejected without assigning any reason thereof In case of submission of defective affidavit / undertaking, the application shall also be rejected
- 1.3 The candidates shall have to furnish a copy of the employment exchange registration card to the effect that she / he has registered his / her name in any employment exchange in the state at the time of verification of certificate

ELIGIBILITY. 2.

For the post of + 2 Arts / Com CT & + 2 Science CT.

Higher Secondary (+ 2 or its equivalent declared by Appropriate Authority with at least 50 % marks and a) CT Training from a recognised Board / University

OR

Higher Secondary (+ 2 or its equivalent declared by Appropriate Authority with at least 50 % marks and 2 years Diploma in Education (Special Education) a course recognised by Rehabilitation Council of India (RCI)

Graduation & 2 year Diploma in Elementary Education / 2 year Diploma in Spl Education

- Pass in Odisha Teacher Eligibility (OTET Category- I) b)
- Candidates must have Odia as MIL up to Class VII or pass in Odia language test equivalent to ME C) standard conducted or declared by BSE (O)

For the post of B.A., B.Ed. & B..Sc. B.Ed.

Graduation with at least 50 % marks and 1 – year Bachelor in Education (B Ed) a)

OR

Graduation with 50% marks and 1 year B Ed (Special Education)

OR

Higher Secondary (+2 or its equivalent with at least 50% marks and 4 years B A B Ed / B Sc B Ed &

- Pass in the Odisha Teacher Eligibility Test (OTET Category II) b)
- Candidates must have Odia as MIL up to Class X c)
- That engagement of all Sikshya Sahayak (SSs) will be made by the Collector under each category i.e. (1) Trained Graduate Science, Trained Graduate Arts (Social Science), Trained Graduate Arts (Language) under the Programme of Sarva Sikshya Abhiyan (SSA) and for implementation of the said Act, TGT (Science) will mean TGT (Physics, Chemistry & Mathematics) or TGT (CBZ / Life Science), TGT Social Science will mean TGT (arts) having any two of the optional subjects such as History, Geography, Political Science and Economics and TGT (Language) will mean TGT (Arts) having Odia or English as one of the optional subjects
- Provided that relaxation of 5 % in minimum qualifying marks in Higher Secondary (+2) or in graduation (11)level, as the case may be, shall be allowed to the candidates belonging to SC, ST, OBC / SEBC
- Provided that if trained candidates having the above percentage of marks in Higher Secondary (+2) or (III)in graduation level, as , as the case may be, are not available and posts remained unfilled, trained candidates having the minimum percentage of marks prescribed at the time of admission in teacher education course with OTET pass shall also be considered for engagement
- The candidates having requisite academic qualification without training qualification with OTET pass (IV) may be considered for engagement only on the basis of qualification so relaxed by the Central Government with the stipulation that such untrained candidates will acquire training qualification within the stipulated date given by the Central Government
- The untrained candidates having the requisite academic qualification required for teacher's training (V) courses as decided by NCTE from time to time and passing of OTET may only be eligible for engagement
- For the purpose of degree in teacher education (B Ed) B Ed degree of other Universities declared (VI) equivalent with corresponding degree of the Universities of Odisha and a course recognised by the NCTE shall be considered
- Untrained candidates selected as per the relaxed standard shall have to furnish an affidavit at the time (VII) of engagement to the effect that they shall acquire the required training qualification within the stipulated period in accordance with the provisions of the Act or as decided by the Government of India from time to time Candidates unable to acquire the training qualification within the stipulated period shall be disengaged automatically
- Candidates who are in employment shall furnish the copy of the no objection certificate issued by the (VIII) employer at the time of joining

3. Selection shall be made only on meritile on the basis of percentage of marks

Explanation.:

- The marks secured in 4th optional or extra optional subject in HSC Examination / Higher Secondary (+2) Examination is to be deducted from the total marks for arriving at the effective percentage of marks.
- In case of compartmental examination the fail marks secured in the subjects is to be deducted from the total marks and pass marks of the compartmental examination shall be added to the total marks for arriving at the effective percentage of marks.
- (b) In case of candidates having qualification of graduation with B Ed the percentage of marks secured by the candidates in HSC Examination + percentage of marks secured by the candidates in pass / Hons Subjects + percentage of marks secured in the B Ed / Spl B Ed examination shall be considered

In case of untrained graduate candidates percentage of marks secured in HSC examination + percentage of marks secured in pass / Honours subjects shall be considered *Explanation*.

- (i) For the purpose of degree in teacher education (B Ed), B Ed degree of other Universities declared equivalent with corresponding degree of the Universities of Odisha and a course recognised by the NCTE shall be considered.
- (ii) While calculating percentage of marks of pass students marks obtained in pass subjects will be considered for calculation of percentage
- (iii) In case of Honours students, marks obtained in Honours subjects will be considered for calculation or percentage
- (iv) For the purpose of Calculation of % of marks, marks secured in extra optional / Ancillary / Foundation courses are to be deducted from the total marks
- (c) In case, two or more candidates secure the same marks, the candidates older in age and if ages are same, the candidates passing High School Certificate Examination earlier will be placed above the other in the select list
- 4. The select list for each Revenue District will be valid for a period of one year from the date of its final publication or till nest advertisement whichever is earlier
- 5. (a) Orders of engagement shall be issued by the concerned Collectors. While issuing the engagement order, the Collector will exhaust the list of selected trained candidates of the required category first and thereafter if need be he / she will fill up the remaining vacancies from the list of selected untrained candidates.
 - (b) The engagement will be on an annual contract basis. Contract will be renewed in subsequent years depending on the performance of the candidate. While renewing the contract of the Sikshya Sahayaks. (SS), the concerned Collectors, must see that the School Management Committee / SMDC of the concerned School has given positive certificates in his / her favour about regular attendance and satisfactory teaching. The Sikshya Sahayaks. (SSs) can be removed from engagement with a prior notice of 30 days, if she / he violets the conditions of the contract or on the basis of adverse report of the School Management Committee / SMDC i.e. on unauthorised absence / misconduct / involvement in criminal cases.

6. <u>AGE.</u>:

Candidates shall not be below 18 years of age and above 35 years of age as on <u>01.01.2015</u>. In case of SC/ST/Women, Ex-Serviceman & SEBC candidates the upper age limit may be relaxed by five years and in case of PH candidates the upper age limit may be relaxed by 10 years

- One third of the posts of SS will be reserved for women candidates of respective categories.
