INVITES APPLICATIONS FOR THE POST OF "VIDYUT SAHAYAK (JUNIOR ENGINEER) - ELECTRICAL"

1. QUALIFICATION :

B.E. (Electrical) or B.Tech. (Electrical) in Regular mode from recognized University with minimum **60%** marks for General category candidates and **55%** for SEBC / SC / ST / UEWS category candidates (Aggregate of **7**th **& 8**th **semester**, first trial without ATKT).

The requirement of percentage mentioned above will be considered as exact percentage and no rounding up of percentage will be allowed for deciding the eligibility of the candidate.

2. AGE CRITERIA: (As on the date of issuance of the advertisement- i.e.04/07/2016)

Relaxation in upper age limit to other categories shall be given as under:

Female Candidates	05 Years
Physically Handicapped Candidates (OL & HH only)	Upto age of 45 Years

Dependent of Retired Employee of PGVCL	Upto age of 40 Years

- Maximum age relaxation in upper age limit shall be considered upto the age of 45 years.
- The above age criteria is as per the "Yuva Swavlamban Scheme" of Govt. of Gujarat.
- The upper age limit shall not be applicable in case of Departmental Candidates.

3. REMUNERATION:

Fixed remuneration for 1st and 2nd year would be Rs.19,750/- and Rs. 21,750/- respectively per month. No other allowances or benefits would be admissible except coverage under Personal Accident Policy, Reimbursement of TA/DA as per Company's rules.

On completion of successful and satisfactory two years services as Vidyut Sahayak (Junior Engineer), the candidates will be appointed on regular establishment as **"JUNIOR ENGINEER"** in the scale of Rs. 17,300 - 38,610 depending on overall performance.

7. GENERAL TERMS AND CONDITIONS :

- 1. Candidates are required to submit <u>ONLINE Application</u> compulsorily.
- Candidates will be shortlisted for Written Test / Personal Interview on the basis of their online applications only and they have to submit the authentic photocopies of all the relevant certificates / documents and subsequently the original certificates / documents for verification.

Only those candidates, who are fulfilling the requisite criteria are advised to apply. If at any stage, it is found that the candidate does not fulfill the requisite criteria, his / her candidature / selection / appointment shall liable to be cancelled.

- 3. For the payment of Non refundable application fees, the bank charges shall be paid by the applicant to the bank over and above application fees. The fees can be paid online through Credit Card / Debit Card / Net Banking or in any of the branches of SBI.
- 4. The reservation for SC / ST / SEBC / Women / PH / UEWS candidates and the state domicile policy shall be as per guidelines issued by GUVNL as per Government of Gujarat directives.
- 5. The management reserves the right to short list, select or rejects any candidate for Written Test / Interview as the case may be for selection.
- 6. The management reserves right to cancel Select list / Waiting list at any time at its sole discretion, without assigning any reason thereof.
- 7. The application will be registered for further consideration only after the payment of requisite application fees is confirmed.
- 8. Caste (Roster category) certificate of Gujarat State only will be considered.
- PH Candidates having disability (40% and above) of One Leg (OL) / Hearing Handicapped (HH) only can apply and shall have to submit valid certificate of Civil Surgeon, indicating existing percentage of disability. Their applications will be considered as per prevailing rules.
- 10. In case of selection, the candidates have to fulfill the requisite Physical Fitness Standard as per Company's rules.

- 11. SEBC candidates shall have to submit a valid Non Creamy Layer Certificate issued on or after 01/04/2016 and caste certificate issued by competent Authority of Gujarat State.
- 12. UEWS (*Unreserved Economically Weaker Sections*) candidates shall have to submit the appropriate certificate issued by the competent authority of Govt. of Gujarat.
- 13. Selected Candidate shall have to work anywhere under the jurisdiction of PGVCL and the candidate selected for the post, shall not be transferred from PGVCL to any other subsidiary Company of GUVNL.
- 14. In case of Name / Surname changed, a copy of Gazette of that effect should be submitted.
- 15. Departmental candidates / Dependent of retired employees of the PGVCL Company, meeting the above criteria also have to apply ONLINE and to submit the required documents.
- 16. Candidates who are working in Government / Semi Government / PSU have to submit the "No Objection Certificate".
- 17. The selected candidates shall have to produce reliving letter from the previous employer at the time of resuming his / her duty.
- 18. PGVCL will not be responsible for any postal loss/delay in receipt of application.
- 19. Canvassing in any form shall debar the candidate from selection.

- > Non-conventional Energy sources like wind, solar, biomass etc.
- > Present power sector scenario in India
