1. The Educational qualification for the post of Junior Assistant shall be minimum graduation from a recognized university or any Examination declared equivalent by the Governmen as per the of Rule 12 of the Assam Directorate Establishment (Ministerial) Service Rules ,2016 . Moreover, a candidate for the post of Junior Assistant must Possess Computer skills for handling data and text on computer.

2. In view of the guidelines issued by the Govt. in the Personal(B) Department vide letter No. ABP.70-A/2016/6 Dated 16 Aug, 2016, there shall be no interview for the post of Junior Assistant and Data processor.

3.In view of the above modifications it is informed that the applications of the candidates who had applied on the basis of minimum qualification of HSSLC in Arts/Science /Commerce in response to our earlier advertisement dated 09/06/2015 in "Amar Axom" and "The Assam Tribune "(Janasanyog/2632/15" Dated 9th June/2015 are hereby cancelled. <u>Age</u>:

The candidate should not be less than 18 years and not above 38 years as on 01.01.2017. The upper age relaxation shall be applicable in case of Reserved Category candidates as per Rules.

Examination:

Candidate will have to appear in a written examination to be conducted by the Directorate of Accounts and Treasuries, Assam.

How to apply:
