#### I. COMPANY PROFILE

TCIL is a Schedule- "A" Mini-ratna CPSE in Telecommunication and Information Technology services sector with the administrative jurisdiction of Department of Telecommunications, Ministry of Communications. The company employed 824 regular employees (Executives 395 and Non-executives 429) as on 31.03.2020.

Its Registered and Corporate offices are in New Delhi.

The authorised and paid up capital of the Company was Rs. 160 crores and Rs. 59.20 crores respectively as on March 31, 2020.

The shareholding of the Government of India in the company is 100%

#### **II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director(Projects) is a member of the Board of Directors and reports to Chairman and Managing Director. He/she is responsible for resource and material management for various ongoing projects including civil and infrastructure. He/she is responsible for providing professional

manpower and materials to Projects in a time bound manner. He/she is responsible for overseeing the proper execution of all projects and for strategic planning keeping in line with the technological changes in the areas of operations of the company and business development.

# 3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
