North Central Railway invites application from the doctors of "Open Market" as well as "Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways)", to engage **37 (Thirty seven)** full-time Contract Medical Practitioners (CMP) General Duty Doctor at CH/PRYJ on Contract basis for a duration of three months as per details given below:

**Note:-**

- (i) Candidates must available for walk in interview through audio /video by **10.00 Hrs.** on 14.04.2020 (Tuesday).
- (ii) Candidate must submit their applications on the prescribed proforma enclosed alongwith relevant documents on **e-mail ID [p.murmu20@gmail.com](mailto:p.murmu20@gmail.com)** .
- (iii) In case, the numbers of candidates are more and they cannot be interviewed on the scheduled date/day, they will be interviewed on the next working day/days.
- (iv) Last date/time of submission of application :- **09.00 Hrs.** on 14.04.2020.

**Educational Qualification :-** MBBS from a recognized University and must have completed one year internship and should be in possession of a valid Registration Certificate issued by any of the State Medical councils/Medical Council of India.

**Remuneration for the doctors of open market:** **Rs.75,000/-** for General Duty Doctor, if Govt. accommodation is not provided. If Railway accommodation is provided, an amount equivalent to the sum of House Rent Allowance and License Fee of the accommodation provided will be deducted.

**Remuneration for Retired Government Medical Officers of State Government/Central Government/IRMS Officers (Railways):** **Rs. 75,000/-** for General Duty Doctor per month fixed {subject to the condition that remuneration + pension drawn by Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways) should not exceed the last pay drawn}, if Govt. accommodation is not provided. If Railway accommodation is provided an amount equivalent to House Rent Allowance payable to a fresh entrant to Group 'A' Jr. Scale and license fee of the Railway accommodation, so provided shall be deducted from the monthly remuneration payable to the CMP.

NOTIFICATION OF DOCTOR (Health)

**Age for the doctors of open market:-** Candidates should not have completed more than 60 years of age as on **14.04.2020**. However, age relaxation of 5 years for SC/ST and 3 years for OBC candidates is admissible.

**Age for Retired Government Medical Officers of State Government/Central Government/IRMS Officers (Railways):-** Candidates should not have completed more than **67 years** of age as on **14.04.2020**.

**Terms and condition for the doctors of open market:-**

The engagement of Doctors would be on contract basis for a period of three months. However, the services of these doctors can be terminated before the expiry period after giving 15 days notice on either side. Railway Administration will be at liberty to terminate the contract of the doctor with immediate effect by paying honorarium in lieu of 15 days notice period, if the circumstances, so warrant. It will also not confer upon them any right for regularization or permanent absorption in the Railways. Contract shall also be terminated, if the CMP is found to be mentally or physically incapacitated.

**Terms and condition for Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways):-**

The engagement of Retired doctors as CMPs shall be for a maximum of **03 (three)** months or till attaining the age of **67 years** whichever is earlier. The engagement shall purely be on contract basis. The Retired Government Medical Officers of State Government/Central Government/IRMS officers (Railways) engaged as Contract Medical Practitioner shall not have any claim or right for his/her continuity in service or automatic extension of the term of contract. During the validity of the contract, the CMP shall be at liberty to terminate the contract for betterment of his/her career or on any other grounds by giving 15 days notice to the Railways. The contract can also be terminated by the Railways at any time during the contract by giving 15 days notice without assigning any reason whatsoever. Contract shall also be terminated, if the CMP is found to be mentally or physically incapacitated.

**No private practice is allowed.**

**Note:-**

- (i) The contract Doctors shall not be entitled for Railway quarter etc. as a matter of right. However, if such a quarter is available, they will be provided accommodation. The detailed instructions with regard to their duties while on contract with the Railways, shall be given to them in the event of their selection along with the offer of engagement.
- (ii) Selected candidates should bring their application form along with **Original and Attested** copies of all Certificates & Mark Sheets, duly filled up on the prescribed format with them at the time of joining. No TA/DA is admissible for this interview.
- (iii) Administration has a right of transfer to selected candidate(s) any time in future from Central Hospital/Prayagraj to Divisional Hospitals/ Health Units situated in the jurisdiction to NCR, if required. The CMP Specialist Doctors so selected shall also have to carry out general duties as and when required by Railway Administration in addition to their specialty work.
- (iv) The number vacancies may be changed as per requirement of the administration.

- (vi) After approval of the panel by competent authority, the panel will be uploaded on same day at NCR's website [www.ncr.indianrailways.gov.in](http://www.ncr.indianrailways.gov.in) . The suitable candidates will be called through speed post/registered letter/Telephone calls and SMS to report in Central Hospital, Prayagraj for posting. The candidates who do not report within the stipulated date and time will forfeit their chance of contract engagement and such engagement will be offered to the next empanelled candidate.
- (vii) The empanelled candidate(s) will undergo medical examination and will execute a "**Contract Agreement**" notarized and duly executed to concerned Personnel Branch. In this regard, instructions will be issued in the offer of engagement of the candidate(s).
