CIRCULAR

It is proposed to fill up 1 (one) post of Revenue Inspector in the (Pre revised) PB I Rs. 5200-22000 with Grade pay of Rs.2400/- and in the revised Pay scale at Rs. 25500/- (Level -1) under Revenue deparment , Collelctorate by direct recruitment. The age and educational qualifications prescribed for the post of Revenue Inspector is as follows:-

Essential:-

- 1.Graduation under any discipline from a recognized University.
- 2.Pass in 3 months Chain Survey (Lower) course conducted by Govt. of Kerala or by any recognized Board.
- 3.Certificate course in Computer for a minimum period of 3 months.

Desirable:-

- 1.Certificate course of minimum 3 months in AUTOCAD.

Age:- Between 18-25 years(Relaxable for Govt.Servants, SC/ST candidates, Ex-servicemen and other special categories of persons in accordance with instructions or orders issued by the Central Govt. from time to time).

Note:- The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates.

The elegible and willing local candidates may submit applications to the undersigned with attested copies of testimonials such as mark list, educational qualifications proof of age, Schedulaed tribe certificate and proof of desirable qualifications mentioned above so as to reach this office by on or before **30.06.2017 at 5 PM**. The applications received after the due date and without attested copies of testimonials will not be entertained and summarilly rejected. The crucial date for determination of age shall be the last date fixed for the receipt of the application i.e 30.06.2017.

There will be a written test as prescribed by the committee as per F.No. 12/28/2013-Services/4417 dated 11.12.2013 of Director(Services), Secretariat, Kavaratti. Written test would be conducted by an external agency for the selection. Question paper for written examination shall have total 100 Nos. of questions, out of which 50% (50 Nos) shall be from the specific concerned subjects and remaining 50% (50Nos) from general knowledge, english language with duration of one and half hours for examination with negative marking. And for every correct answer one mark will be awarded and for every wrong answer 1/3mark would be deducted. Cut of criteria would be 45% as prescribed vide F.No. 12/28/2013-Services dated 11.12.2013.
