RESULT FOR VERIFICATION OF CERTIFICATE

In order to take care of the shortfall in the formation of the original panel, the number of candidates being called for document verification is 50% more than the actual number of vacancies (wherever such number of candidates is available). It is also made clear that merely calling a candidate for document verification does not in any way entitle him/her for final empanelment/appointment on the Railways. The candidature of all the above mentioned candidates are purely provisional and subject to correction/amendment arising out of their entitlement and eligibility in all respects for which the administration reserves the right to rectify the error at any stage from empanelment to appointment, and even after appointment.

Candidates who fail to attend the Verification of Certificate (VOC) on the scheduled date shall be given 2nd chance for VOC on 31.07.2017 but such candidates should have a valid reason with supporting documents for not attending the VOC on their scheduled date. No separate call letter will be issued for 2nd VOC. No further chance will be given for VOC or submission of certificates and the candidature of the candidates will stand cancelled.

INSTRUCTION TO THE CANDIDATES FOR ATTENDING DOCUMENT VERIFICATION

1. The candidates are hereby directed to bring all the relevant documents IN ORIGINAL along with one set of Photostat copies duly attested/self-attested in respect of—
 - (a) Date of Birth proof and matriculation (SSLC/ Matric / 10th certificate),
 - (b) Pre-degree/10+2/Higher Secondary/ Inter (Where applicable),
 - (c) Educational qualification proof as mentioned in the employment notification for the above said post(s)(all mark sheets, Diploma/Degree certificate Issued by University/AICTE only),
 - (d) Community (SC/ST/OBC) proof in the prescribed format (Annexure-3/Annexure-4 of CEN No. 03/2012) issued by competent authority with proper seal and designation of the issuing authority. Please note that OBC candidates have to submit latest community certificates with non-creamy layer certification which is not more than one year old as on the date of verification.
 - (e) "Minority Community Declaration" affidavit format as per Annexure-8 of CEN No. 03/2012 on non-judicial stamp paper that he/she belongs to the minority community having claimed exam fee exemption. If the affidavit is not produced at the time of document verification the candidature will be rejected as per para 3.08 of CEN No. 03/2012,
 - (f) Income certificate in the prescribed format as per Annexure-7 of CEN No. 03/2012 having claimed exam fee exemption. If the income certificate is not produced during the document verification the candidature will be rejected as per para 3.09 of CEN No. 03/2012,
 - (g) PWD Proof (If applicable) as per Annexure-9 of CEN No. 03/2012,
 - (h) Ex-serviceman proof (No objection certificate/ Discharge certificate, PPO, Ex-serviceman Book & Identity card etc.).

- (i) No objection proof (NOC) from the competent authority, if already employed in Railway or any Government department /public sector undertaking with all services particulars (Date of appointment, present designation etc.).
3. Candidate must ensure that his/her name, date of birth, father name and other particulars in the original certificates match with entries made in application.
 4. In case of variation in name /father's name/initial etc. necessary affidavit to be obtained from notary stating the name as filled in application and that appearing in all certificates refers to the same person and submitted at the time of verification.
 5. You are also required to submit 02 copies of your recent passport size colour photograph.
 6. Candidates may be required to stay for more than one day, if necessary.
 7. **Free Travel pass for SC/ST candidates will be printed on the lower portion of call letter for VOC.** At the time of obtaining reservation and travelling, the reservation Clerk or Ticket checking staff will ask for original SC/ST certificates for verification of genuineness of the candidate.
 8. The onus of proving the eligibility for the post concerned and the genuineness of the other averments made in the initial application shall rest with the candidates. Their candidature would be purely provisional and would be liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency is noticed at the stage of document verification or later.
 9. **No further time will be allowed for submission of certificates.**
 10. As per para 14 of CEN No. 03/2012 furnishing any false information to the RRB or using unfair means in the examination or deliberate suppression of any information at any stage will render the candidate disqualified and debarred from appearing at any selection or examination for appointment on the Railways or to any other Govt. service and if appointed the service of such candidate is liable to be terminated.
 11. The final selection of the candidates will be subject to number of vacancies available, performance in the Computer based examination and verification of all original certificates and satisfaction of all prescribed criteria.
 12. Candidates once empanelled for any of the posts depending on his/her choice/ merit position will not be considered for alternative appointment later if he/she is found medically unfit.
