1. Job Profile:

(1) PORT MANAGER

The Port Manager will be responsible for planning, coordinating and monitoring day-to-day activity of Port Operations at the LNG Terminal.

(2) DY. PORT MANAGER

The Deputy Port Manager will assist the Port Manager in planning, coordinating and monitoring day to day activity of Port Operations at the LNG Terminal which includes mooring, unmooring, safe keeping of vessel at berth, monitor jetty control room activities etc. He will be responsible for HSE functions at the Terminal.

2. Period of Contract:

The contract for shall be from the date of engagement till 15th May 2018 and may be extended by period of 8 months from 15th Sep 2018 to 15th May 2019 at the discretion of SCI.

3. Emoluments:

(i) Port Manager: Consolidated emoluments of Rs. 2,25,000 /- per month (all inclusive-CTC).

(ii) Deputy Port Manager: Consolidated emoluments of Rs. 2,00,000 /- per annum (all inclusive-CTC).

No other benefits/perks will be provided. Income Tax will be deducted at source as per prevailing rules.

4. Age:

5. Accommodation:

No Company accommodation will be provided to the officers during the contract period.
