Applications are invited from eligible candidates for appearing at the Odisha Teacher Eligibility Test (OTET), 2017 (1ST) as per the following guidelines :-

1. Applications shall be received through ONLINE mode only on visiting the website "[www.bseodisha.ac.in](http://www.bseodisha.ac.in)".
2. ONLINE link will be available (24 × 7) from **23/08/2017** 8 am to **06/09/2017** 11.45 pm.
3. The payment of fee shall be done through SBI Collect either in online or offline mode latest by 11.45 pm of **06/09/2017**. However filling up of forms through online can be carried out till **07/09/2017** midnight.
4. The step by step instructions for online registration, applicability & eligibility of candidates, qualifying criteria, syllabus & its structure, instructions for physical handicapped candidates & format for continuing certificate are available in the website "[www.bseodisha.ac.in](http://www.bseodisha.ac.in)".
5. A candidate can apply for only one paper. The candidate eligible to apply under Category-B (Paper-II), shall not be eligible to apply under Category-A (Paper-I). In case the candidate register under both the papers, his/ her candidature in both the papers shall be rejected.
6. Under no circumstances the last date for submission of application forms shall be extended.
7. The candidates can download their Admit Cards from the website "[www.bseodisha.ac.in](http://www.bseodisha.ac.in)" by entering their **Registration Number & E-Mail ID** from **12/09/2017**. The change of examination centre is not permissible. The hard copy of the Admit Cards shall not be issued by the B.S.E., Odisha.
8. The Examination shall be conducted on **25/09/2017 (MONDAY)** as per the programme given below :-






