Officer in charge (Sl-01), Counselor (Sl 02), Child Welfare Officer)/Case Worker /Probation Officer (Sl 03) & Storekeeper cum Accountant (06) : 10 marks.

House Mother(Sl 04), House Keeper (Sl 07) & Para Medical Staff (Sl 05) : 20 marks.
