III. AGE:

Age limit will be followed as per Apprenticeship Rules.

IV. RESERVATION OF VACANCIES:

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed.

V. MINIMUM PHYSICAL STANDARDS:

As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.

VI. **DURATION OF TRAINING:**

The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act 1973.

VII. PREVIOUS TRAINING/EXPERIENCE:

Candidates who have already undergone or are currently undergoing apprenticeship under Apprentices (Amendment) Act 1973, and/or having one year or more experience are **not eligible to apply**.

VIII. <u>SELECTION PROCEDURE:</u>

Board of Apprenticeship Training (SR) is entrusted with the task of preparation of shortlist from the online application data. Shortlisting of candidates will be done based on the percentage of marks obtained in the basic prescribed qualification as applicable to the respective disciplines. Shortlisted candidates shall be intimated through their registered Email id. Shortlisted candidates have to appear for Certificate Verification at Board of Apprenticeship Training (SR), Chennai.

- IX. TRAVEL EXPENSES: No TA / DA will be paid for attending certificate verification.
- X. **BOARDING/LODGING:** No boarding or lodging expenses are admissible
