

3.	Qualification Section 3(3)(b) of the W.B. Taxation Tribunal Act, 1987.	3. Establishment of Tribunal, composition and functions thereof:- (3) No person shall be qualified for appointment – (a) ..... (b) as a Judicial Member unless he has been, or is qualified to be, a Judge of a High Court.
4.	Term of Office Section 3 (5) of the W .B. Taxation Tribunal Act, 1987	3. Establishment of Tribunal, composition and functions thereof:- (5) A Judicial Member shall hold office for a term of five years from the date on which he enters upon his office, but he shall be eligible for re-appointment for another term of five years : Provided that no Judicial Member shall hold office as such after he has attained the age of 65 years.
5.	Condition of Service	The conditions of service of Chairman and Members shall be guided by the W.B. Taxation Tribunal (Salaries, Allowances and Conditions of Service of Chairman and other Members) Rules, 1988.
